

## The Total Woman Show Door Prize Contest Rules & Regulations

1. **Agreement:** These rules govern the Total Woman Show Door Prize contest (the “Contest”). No purchase is necessary to enter the Contest. The act of entering the Contest constitutes acceptance of the Contest rules and the decisions of the Sponsor, which decisions shall be final and binding on all entrants.
2. **Sponsor:** The Contest sponsor is Waterloo Region Record, a publication of Metroland Media Group Ltd. (the “Sponsor”).
3. **Eligibility:** The Contest is open to residents of Ontario that have reached the age of 18 as of the start of the Contest Period. Notwithstanding the above, the Contest is not open to employees, immediate family members (i.e. spouses or biological, step or adoptive parents, children or siblings) or anyone domiciled with any employee of the Sponsor or its subsidiaries, affiliates, advertising and promotional agencies or fulfillment houses. To enter the Contest via the method above without paying the show admission fee, please ask at the show’s Exhibitor Registration Booth and a volunteer will escort you to the booth to complete your entry. After the ballot is deposited at the ballot table, the volunteer will escort you back to the exit.

The potential winners will be contacted by telephone or email by a representative of the Sponsor, and must reply within forty-eight (48) hours to maintain eligibility. If a potential winner cannot be contacted within this time period or fails to respond to any attempted contact or incorrectly answers the skill-testing question, such potential winner will be disqualified, his/her entry will be declared null and void and the Sponsor reserves the right, in its sole and absolute discretion, to select at random another eligible entry, in which event these provisions shall apply to such other eligible entry.
