

Food & Drink Door Prize Contest Rules & Regulations

1. **Agreement:** These rules govern the Wedding Trends Door Prize contest (the “Contest”). No purchase is necessary to enter the Contest. The act of entering the Contest constitutes acceptance of the Contest rules and the decisions of the Sponsor, which decisions shall be final and binding on all entrants.
2. **Sponsor:** The Contest sponsor is Waterloo Region Record, a publication of Metroland Media Group Ltd. (the “Sponsor”).
3. **Eligibility:** The Contest is open to residents of Ontario that have reached the age of 18 as of the start of the Contest Period. Limit of one (1) entry per person. To enter the contest and be eligible to win a prize, read these Contest rules, pick up the Food & Drink Show Prize ballot from the entry gate at The Food & Drink Show held at The Kitchener Aud, 400 East Avenue, Kitchener ON N2H 1Z6, complete the ballot with all required information and deposit the ballot into the ballot box.
5. **Winner Selection:** The winners will be chosen by random draw, which will take place on April 26, 2017 at 10:00 a.m. ET. The potential winners will be contacted by telephone or email by a representative of the Sponsor, and must reply within forty-eight (48) hours to maintain eligibility. If a potential winner cannot be contacted within this time period or fails to respond to any attempted contact or incorrectly answers the skill-testing question, such potential winner will be disqualified, his/her entry will be declared null and void and the Sponsor reserves the right, in its sole and absolute discretion, to select at random another eligible entry, in which event these provisions shall apply to such other eligible entry. In order to be eligible to win, each potential winner must correctly answer a mathematical skill-testing question without assistance or mechanical or electronic aid.
